

## DBBI Premier League Information

- Available for these age divisions: 7U, 8U, 9U, 10U and 11U. Age division is determined by your **player's age PRIOR to May 1, 2026**. The North Texas area Premier League does NOT have a program available for 12 yr olds or 13-14 yr olds.

DBBI is considering the 14U REC age division possibly interlocking with other 14U REC teams in the North Texas area to get them ready for high school team travel.

- Register/pay for your player in REC program according to their age division. **Tuesday, Aug. 5 they must participate in their age division Premier League try-out.**
  - 7U: 6pm – 6:45pm
  - 8U: 6:45pm – 7:30pm
  - 9U: 7:30pm – 8:15pm
  - 10U: 8:15pm – 9pm
  - 11U: 9pm – 9:45pm
- 1 team per age division, 11 players per team – 10 selected by committee + 1 the age division coach chooses (which would probably be his player IF the committee selected his player based on their skill level)
- 12 game schedule – double headers on Sat, Sun or Sat and Sun with other Premier teams
- Premier League has their own age division End of Season tournaments
- Cannot participate in any select tournaments
- There is not a Premier League age division team for 12U or 14U – there is a DFW Rec interlock.
- If selected – additional \$120 fee to be added to your account (2 game jerseys, cap, practice jersey).
- Premier League has their own age division End of Season tournaments
- Premier League teams cannot participate in any Select tournaments
- There is not a Premier League age division team for 12U or 14U – there is a DFW Rec interlock.
- Application process for coaches – an appointed committee will select each age division's coach in regard to the player's selection for that age division. (Coach Application is available on the second page of this document.)
